

Company Life Membership

For Company Members who cease to live in Japan but plan to visit up to 60 days a year or return to live in Japan in the future, Company Life membership may be an option to consider.

The Member must have been a dues-paying Company Regular Member in good standing—meeting all financial obligations and having committed no House infractions—for a minimum of 3 years before a conversion to Company Life membership can be completed. (This rule applies to any Member who joins the Club after August 1, 2024)

Conversion to Company Life membership requires a ¥125,000 conversion fee and ¥75,000 deposit.

CLUB USE GUIDELINES

- When a Company Member converts to Company Life membership, the company may retain or give up the vacated company slot.
- A Company Life Member in good standing visiting Japan may use the Club facilities for up to 60 days per calendar year. A daily fee of ¥1,200 is charged per membership for use of the Club facilities.
- Membership status conversion is necessary if a Company Life Member wants to use the Club facilities for more than 60 days per calendar year.
- Regardless of membership status, Members are prohibited from being registered as a guest while visiting the Club.
- Company Life Members must check in at Member Services or Guest Relations and show their passport, return ticket, reservation confirmation or other official documentation as proof of continuous residence outside of Japan.
- Conversion to Life membership shall be null and void should the Member remain in Japan into the second calendar month after the month of conversion. In such a case, the Member's membership status shall revert to their previous membership category and the Member will incur dues and assessments from the date of conversion to Life membership. The conversion fee shall be refunded to the Member's account and used to restore their deposit.
- Company Life Members enjoy full reciprocal club privileges.
- Company Life Members returning as residents of Japan have three membership options:
 - Company Transfer membership with no transfer fee.
 - New Company membership while paying the balance between the company full entrance fee and the company transfer fee.
 - Resident Full membership while paying the balance between the resident full entrance fee and the company transfer fee.
 - All returning Company Life Members must pay an additional ¥125,000 to maintain the mandatory deposit of ¥200,000.

Please contact the Membership Office for details of your particular membership status.

- Members are ineligible for transfers, changes or conversions while their membership is in a state of delinquency. Members converting to Company Life membership can settle their final statement by credit card.
- Company Life Members have no voting privileges.
